



Lives Transforming Group – Life Coaching Services

Scope and Payment

The client agrees to engage Lives Transforming Group, Inc. (provider) for life coaching services. The client understands that the provider will provide life coaching services for a minimum of one hour per week to be charged at the following rate: \$ _____ per hour, payable to Lives Transforming Group, Inc., as a programmatic activity approved by the IRS in accordance with the provider's 501(c) (3) non-profit determination. Additional communication between the client and provider beyond the one hour per week may be available via text, email, and cell, as mutually agreed upon by both parties, and charged accordingly.

Both client and coach understand that they can terminate the relationship at any time with courteous correspondence as to said intentions. The nature of the coaching-client relationship is built on regular assignments and clear motivation by client to engage in self reflective work in and outside of the coaching sessions. If at some point the client feels unable to proceed in this manner, services can be discontinued until client decides to re-initiate. The provider also has the right to terminate or suspend the relationship at any time the provider determines the client is not moving toward the agreed upon goals or for any other reason the provider may deem it necessary to alter the relationship.

Client Responsibility

The client agrees that the service of life coaching is requested at the client's own choice and with inherent singular responsibility. Any actions or lack of actions taken by the client based on the life coaching activities is at the sole discretion and responsibility of the client and is neither the responsibility nor liability of the provider or its representatives. The client takes full responsibility in the decisions they make from the coaching experience as well as the consequences. The client enters into life coaching with the full understanding that they are responsible for creating their own results.

Legal Disclaimer

Life coaching is a service that provides personal coaching to specific individuals and/or groups. The client is aware that coaching is in no way to be construed as or substituted for psychological counseling or any other type of therapy or medical advice. The client understands and acknowledges the coach will not be liable, legally or otherwise, for the actions the client may or may not undertake as a result of the life coaching sessions. No assumption of responsibility is made, or given, and the client requesting such coaching agrees not to hold the provider or any of its representatives responsible or liable in any form or fashion for such actions taken of their own accord. The method and process by which the provider administers life coaching activities in no manner whatsoever, written or verbal, constitutes an agreement or liability on the part of the provider and it is acknowledged to be different in many ways than clinical and/or medical counseling. The client agrees that using any of provider's life coaching services are entirely at their own risk. Life coaching services are provided "as is", without warranty of any kind, either expressed or implied, including any warranty for information services, coaching, uninterrupted access, or products and services provided through or in connection with the service.

Emergency

By signing this document, the client agrees that certain situations including emergencies and crises are inappropriate for traditional on-line, phone, or face-to-face life coaching services.
